It started in 2006. Harry Harelik, collaborating with the Bernard & Audre Rapoport Foundation, envisioned a program to assist students whose families have no college experience. This vision led to the creation of the Bernard & Audre Rapoport McLennan Community College First Generation Scholars Program, a program that selects 12-15 first generation students each year. That same year during a class at AJ Moore Academy of Waco ISD, Denise Rodriguez listened intently as a representative from McLennan spoke of the various programs and opportunities available, including the new program for first generation



students. Upon her graduation from AJ Moore in 2006, Denise Rodriguez was selected to be a part of the First Gen program's inaugural year.

"I am grateful for all of the wonderful experiences I had with the First Generation program," says Denise (*pictured left*). "Not only was I given the opportunity to further my education with this program — something I did not believe was possible — but I also met wonderful mentors at MCC." Denise credits the First Gen program and her mentors for her success in completing her Associate of Arts in Business and continuing her education at McLennan's University Center, where she received her Bachelor of Business Administration with Summa Cum Laude honors from the University of Texas at Arlington. Denise believes McLennan provided her with the foundation needed to succeed.

"My most important goal moving forward is to continue giving back to my community. I believe I have the honor and an obligation to invest in my community, specifically by serving as a mentor and providing financial assistance to other first generation students."

Denise currently lives and works in Waco, and she hopes to return to school to pursue her Master of Business Administration. The Bernard & Audre Rapoport McLennan Community College First Generation Scholars Program continues to help students like Denise. GETTING THE MOST BANG FOR YOUR TAX BUCK WITH Charitable contributions

Often, the largest gifts to charitable organizations (501(c)(3) nonprofit organizations) materialize through estates because at death, one no longer worries about cash flow. However, under the new estate tax laws, which exempt all estates up to slightly over \$5 million, few estates are taxable and therefore, while charitable giving through estates is still essential for nonprofit financial survival, there is no longer a tax savings in most estates for those charitable gifts.

If one wants to make gifts to charity AND also would like a current income tax deduction (and tax savings), the gifts almost always must be made during one's lifetime. This could require some planning! Charitable gifts during life are accounted for through itemized deductions on one's income tax return. Every person or couple who files an income tax return has the choice of taking a deduction of the higher of actual itemized deduction (which includes charitable gifts) or the standard deduction. **Itemized deductions** may include medical expenses which exceed 10% of adjusted gross income (or if tax payer is 65 years old or more — 7% of adjusted gross income), property taxes, some types of interest expenses, state sales or income taxes, miscellaneous deductions which exceed 2% of adjusted gross income and, of course, charitable contributions. However, if the standard deduction exceeds the total of itemized deductions, then one would take the standard deduction to save more income tax. Available **standard deductions** are quite advantageous: For 2014, for instance, these were:

Joint/surviving spouse \$12,400, Head of Household \$9,100, Single or Married Filing Separate \$6,200

For taxpayers whose itemized deductions don't exceed the standard deduction, charitable contributions won't affect income taxes because itemized deductions won't be used in the tax calculation. But one can plan **timing** charitable contributions to get a better result:

For instance, if the total itemized deductions, filing jointly, were at \$11,800 without the charitable amount, and the charitable amount was generally \$550 annually, then for 2014, the normal total with the charitable gifts would be \$12,350, and not higher than the standard deduction. But if one were to **"bunch"** the charitable deductions for two years into one year, then the total itemized deductions would be \$11,800 plus \$550 (one year) plus \$550 (second year) or \$12,900. This would then exceed the standard deduction, and the taxpayer would have a little tax advantage.(The charitable contributions for year one could be made January 1st of year one and the charitable deductions for year two could be made December 31st of year one.)

Alternatively, the charitable contributions could be made directly at one time to a donor-advised fund at a community foundation (such as Waco Foundation) with directions to distribute to the charity in two separate years; the deduction is achieved in one year but the charity(ies) would receive the funding in two separate years. A little planning can help the tax situation, but timing of the deduction is only one part of the planning.

In what form the deduction can be made is another part of the planning. For instance, with the MCC Foundation, gifts can be made to: **capital campaigns** (such as the All-Steinway Campaign or the Health Professions Complex Campaign), the **general endowed scholarship fund** or a specific scholarship fund, the **Professional Development Fund** for staff and faculty, any of the special student travel study programs or even through the **charitable gift annuity program.*** Donors can initiate an endowed fund in their own name or in honor of someone else, as well, and then contribute to that annually over a period of years to fund it.

Finally, if one decides not to give during life to the MCC Foundation and not to bequest something at death either, the donor can still "contribute" by directing his heirs to list the MCC Foundation as a charity of choice in the obituary and friends and family can donate to the MCC Foundation in memory of the donor. This won't cost the donor anything at all.



*(In the charitable gift annuity program, donors can reserve income for life from their gift at a high rate of return with any remaining funds, at donor death, going to a fund at the MCC Foundation. The present value of the charitable gift annuity can provide a current income tax deduction.)
