

Longtime Waco Insurance Agent Honored with Endowed Scholarship

The Independent Insurance Agents of Central Texas (IIACT) recently honored longtime Waco insurance agent Champe Fitzhugh, Jr. by presenting a \$15,000 check to the MCC Foundation for an endowed scholarship in his name.

The announcement, which was a surprise to Fitzhugh, was made at a May 9 dinner following the IIACT Big "I" Classic. Fitzhugh, a third-generation insurance agent, has been in the insurance industry for more than 60 years and has been extensively involved in community work. In the early 1960s, he served on the study committee that recommended forming MCC, and he also served as chairman of the education committee of the Waco Chamber of Commerce. In years since, he has privately funded scholarships and books for many MCC students.

Upon presentation of the check, Greg Vanek, CEO of National Lloyds, pledged an additional \$1,000 toward the scholarship. The Champe Fitzhugh Scholarship is one of 13 new endowed scholarship funds set up at the Foundation so far this year.

Texas Nurses Association contributes to Allen M. Hamilton Nursing Scholarship

A nursing scholarship established to honor longtime MCC Nursing instructor Allen M. Hamilton was bolstered this month with a \$500 contribution from the Texas Nurses Association District 10.

Representatives of TNA District 10 gathered June 26 in the MCC Advanced Skills Nursing Lab to present the check to Foundation Executive Director Harry Harelik. While given in honor of their friend and fellow TNA member Allen Hamilton, who retired in 1999 after a 28-year career as a nursing instructor at MCC, the donation was also given in memory of former MCC Health Sciences division director Janice Roberson. Roberson was killed on Valentine's Day 2003 in an auto/bus crash on I-35. An already fully endowed scholarship fund in Roberson's name was established shortly after her death.

In total, TNA District 10 fundraising efforts have contributed \$3,450 of the funds needed to endow the Allen M. Hamilton Nursing Scholarship. TNA District 10 comprises professional nurses and nursing educators from a 17-county region in Central Texas.

Willpower: Putting your will to work through planned giving

How will you be remembered? It's an important question, but one that doesn't get much thought as we go about our daily routines. As many MCC Foundation donors have learned, supporting the MCC Foundation through planned giving is a truly meaningful way to build a significant legacy for themselves, friends and loved ones. It is a way to either continue support started during life or initiate giving that was previously unaffordable.

Planned giving is simply the concept of including the MCC Foundation in your will, retirement, or estate planning. As much as we may want to, many of us just aren't able to make a significant gift to charity while maintaining our current standard of living. However, building a gift into your estate planning can achieve many of the same benefits as a gift given today, especially when you use the planned giving tools of charitable gift annuities and bequests. What's more, planned giving enriches the MCC Foundation by helping build future security.

A **charitable gift annuity** is simply a contract with the Foundation in which you agree to make an irrevocable donation of property, usually cash or marketable securities. In return, the Foundation agrees to make fixed payments at above-average interest rates for the lifetime of one or two people (annuitants.) Any assets remaining at the death of the annuitants go to the Foundation. Charitable gift annuities are an excellent choice for those who want to assure themselves a dependable source of income in their later years while avoiding management issues and still providing for a charity after death.

A **bequest** is the transfer of property (real estate, securities, money) to a charitable organization through one's will. Bequests provide donors both capital gains tax and income tax benefits. And, unlike other planned giving vehicles that can be complicated to set up, bequests are easy to understand and easily revocable should the family's circumstances change. A bequest can be set up as a defined amount or a percentage of the total estate.

When considering planned giving, give some thought about what you would like the money to support. At the MCC Foundation, it can support one or more endowed scholarships, capital improvements on the MCC campus, or professional development opportunities for faculty and staff.

For instance, a named endowed scholarship is special because of its permanence and enduring benefit to students. Because the initial gift of an endowment is never spent, the scholarship never "dries up" or goes away. Instead, the money is wisely invested, and proceeds from the investment fund a scholarship award each year in honor of the namesake *forever*. A total gift of \$15,000 is needed to fund an endowed scholarship, or \$25,000 for an endowed **presidential** scholarship. The funds can be added all at once or a little at a time (however, the scholarship cannot be awarded until the endowment is fully funded and begins earning interest.) Naming an endowed scholarship fund as your charity of choice in an obituary is an excellent way to let friends and loved ones know how to honor your wishes.

A gift given through planned giving can be a "quiet" way to support a charitable cause. But because planned

gifts deserve as much recognition as gifts made during life, the MCC Foundation has established the Highlander Legacy Society to honor those who include the Foundation in their estate planning. Legacy Society donors are recognized with a special award and a private dinner with the college president and foundation staff.

Planned giving may seem complicated, but with the guidance of your financial planner and the MCC Foundation, it is a wonderful way to permanently make a difference for MCC and for the future of our community. MCC Scholarship Night to feature District Judge, MCC Alum Vicki Menard

In the mid-1980s, Vicki Menard was much like many MCC students: attending classes at night and juggling her college courses with her responsibilities to her husband and children. A few semesters later, she continued her college career at Baylor University and then Baylor Law School. In 2005, after a notable law career in Waco, she made history as McLennan County's first female district judge when the governor appointed her to fill an unexpired term at the 414th District Court. A year later, she was elected to a four-year term on the bench, where she handles a large load of civil and family law cases.
