The largest single donation ever received in McLennan Community College's history was announced Sept. 3 at the MCC Foundation's annual scholarship reception. The \$575,000 gift from Waco philanthropists Jim and Nell Hawkins will fund a water feature plaza and two stained-glass art pieces



adorning the new science building that will be complete in 2009.


#### ALUMNI UPDATE

## MCC Faculty Profile: Dr. Arvis Scott

Hometown: Jasper, Texas (in deep southeast Texas, the Piney Woods region)

**Courses teaching this semester:** Freshman Composition I and American Literature to the Civil War

**Favorite quote:** "Only those who dare to fail greatly can ever achieve greatly." —Robert Kennedy, 1966 (one of my heroes)

What book are you reading right now? I just completed *Same Kind of Different as Me*.

Who is your favorite author? As an English teacher, it would be difficult to list one favorite author. I have many: Herman Melville, Edgar Allan Poe, James Baldwin, Toni Morrison, William Faulkner, Nathaniel Hawthorne, Frederick Douglass, Doris Kearns Goodwin, Richard Wright ... just to name a few.

Name three jobs you've had. I have worked at my family's funeral home as a secretary; I have taught high school English; I worked as a Pepsi girl in a grocery store after graduating from college until I found a teaching job.

**Best advice you ever received:** "Do the right thing and you don't have to worry."

What do you consider the greatest skill a student should have? A strong work ethic.

What is the most valuable thing you have learned from a student? One of the most valuable lessons I learned occurred when I first started teaching at MCC. I did not use the title of Dr. in my classes. I

was a little self-conscious. When one of my female students found out I had a Ph.D., she said I should use it and tell all of my students. She said it was inspirational for her—I was a role model of what a woman (a person) could achieve. I had never thought of it that way.

If you could spend a day with any literary figure, who would you pick? Why? If I could spend a day with two literary figures, one would be Mark Twain. I would like to ask him what he thought of the controversy surrounding his book *Huckleberry Finn*. The other would be Zora Neale Hurston. If I could spend the day with two male historical figures, one would be Martin Luther King Jr. The other would be Franklin D. Roosevelt. If I could spend the day with two historical female figures, one would be Jackie Kennedy, and the other would be Ida B. Wells-Barnett, who worked tirelessly to awaken society to the horrors of lynching in the late 19th and early 20th centuries. She was a courageous woman.
