Mr. Holt called the regular meeting to order at 7:00 p.m. Dr. McKown introduced the guests present at the meeting.

Dr. McKown presented the following Consent Agenda Items for Board approval: 1) Consideration of and Approval of Minutes of July 5, 2016, and July 23, 2016; 2) Consideration of and Approval of Financial Aid Verification Services; 3) Consideration of and Approval of Default Management Services; 4) Consideration of and Approval of Online Tutoring; 5) Consideration of and Approval of Upgrade of Technology Infrastructure; 6) Consideration of and Approval of Technology Training and Software; 7) Consideration and Approval of Academic Freedom Responsibility and Tenure Policy; 8) Consideration and Approval of Submission of the Grant Application for the Texas Conversion to the National Incident-Based Reporting System (NIBRS) to the Office of the Governor; and 9) Appointment of Personnel: Assistant Professor, Associate Degree Nursing (Two Positions), Assistant Professor, Accounting, Assistant Professor, Biology, Coordinator, Wellness, Career Navigator, Adult Education and Literacy. The Board reviewed the resolution declaring the intent to raise McLennan Community Junior College District property taxes for 2017 tax year to an amount in excess of the 2016 tax levy, calling, and setting the dates of public hearings to receive comments on the proposed increase and directing the publication of notices of the public hearings as required by law. Ms. Watley moved to adopt a Resolution with the intent of raising the tax rate above the calculated effective tax rate but below the rollback rate. The intent being to set a rate in the regular board meeting in August at \$.148898 per \$100 property valuation. Mr. McDurham seconded the motion. The motion carried unanimously.

Mr. Holt presented information regarding the McLennan County Appraisal District Budget.

Mr. Holt stated no action was needed regarding the McLennan County Appraisal District Budget.
