Dr. Balmos introduced Dr. Fred Hills, who presented the Student Success Initiative on LEAP. (D.F. V-129)

Mr. Ricky Turman reported on his experience at the Association of Community College Trustees' Governance Leadership Institute in Washington, DC, on August 1-3, 2016.

At 8:35 p.m., Mr. Holt announced that the Board wished to meet under Closed Session and cited V.T.C.A. Government Code, Section 551.074, *To Deliberate the Appointment of, Employment of, Evaluation of, Reassignment of, and Duties of, Discipline of, or Dismissal of Employees* and V.T.C.A. Government Code, Section 551.071, *Consultation with Attorney (Sandy Creek Litigation and Attorney Client Privileged Information)*.

At 8:53 p.m. Mr. Holt reconvened in Open Session and announced that no action had taken place during the Closed Session.

Dr. McKown requested approval of the following Order Adopting District Property Tax Rate: (D.F. V-130)

McLENNAN COMMUNITY COLLEGE ORDER FOR 2016 TAX LEVY

It is ordered that the tax rate for the McLennan County Junior College District for the calendar year 2016, for the ensuing school year, be set at \$0.148898 per \$100 taxable value; and that tax for said calendar year 2016 for said ensuing school year, be, and it is hereby levied at said rate of \$0.148898 per taxable McLennan County valuation on taxable property in said district, \$0.036796 of such rate to be levied for debt service and \$0.112102 of such rate to be levied for maintenance and operation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 4.28 PERCENT AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$3.21.

It is resolved that an exemption from District taxes be allowed on the 2016 tax roll for all residential homesteads for which a valid residential homestead exemption application has been timely filed with the McLennan County Appraisal District, said exemption being for taxes applicable to the first twenty per cent (20%) of the appraised market value of such residential homesteads, or to the first \$5,000 of appraised market value of such residential homesteads.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of persons 65 years of age or older be exempt, pursuant to Article VIII, Section 1-b of the Constitution of the State of Texas.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of individuals who are disabled be exempt from taxation, pursuant to Article VIII, Section 1-b of the Texas Constitution and Section 11.13 of the Property Tax Code. An individual who is eligible for both the 65 years of age or older exemption and the disabled person exemption shall be entitled to only one of these exemptions, and may choose either.

Be it further resolved that the McLennan County Junior College District hereby prescribes that Property Tax Code provisions implementing the tax relief amendment to the Texas Constitution concerning the appraisal of Agricultural and Timber Lands, shall be implemented and effective in the 2016 tax year as prescribed in the above cited statutes.

Be it further resolved that said tax be assessed and collected by the Tax Assessor-Collector of McLennan County, Texas, as provided by law.

Johnette McKown President Mr. Turman moved that the property tax rate be increased by the adoption of a tax rate of 0.148898, which is effectively a 4.28 percent increase in the tax rate. Mr. McDurham seconded the motion. The motion carried unanimously.
