Mr. Holt, Chairman of the Board, called the meeting to order at 7:00 p.m. Dr. McKown introduced the guests present at the meeting.

Dr. McKown presented the following Consent Agenda Items for Board approval: 1) Consideration of and Approval of Minutes of January 17, 2017 Board Meeting; 2) Consideration of and Approval of Revisions to the 2016-2017 Budget; 3) Consideration of and Approval of Revisions to the Core Curriculum; 4) Consideration of and Approval of Receipt of Rad Tech Equipment; and 5) Appointment of Personnel: Project Director, Student Support Services. Mr. Turman moved to approve the Consent Agenda Items, with *Consideration of and Approval of Revisions to the Core Curriculum* item removed. Ms. Watley seconded the motion, and it carried unanimously.

Dr. Hills presented information regarding revisions to the Core Curriculum. (D.F. V—154)

Mr. Sheehy moved to approve revisions the Core Curriculum as presented. Ms. Chavez seconded the motion, and it carried unanimously.

Mr. Gooch presented the financial report for January 2017. (D.F. V—155)

Mr. Stinnett moved to approve the financial report for January 2017 as presented. Ms. Chavez seconded the motion, and the motion carried unanimously.

Dr. Balmos introduced Ms. Londa Carriveau and Dr. Scott McClanahan who presented the Student Success Initiative: *MCC and WISD: A Look at a Dual Credit Partnership*. (D.F. V—156)

Dr. Balmos introduced Ms. Alisa Petree who presented a Teaching Moment Presentation: *Teaching and Utilizing Genomic and Biotechnology Skills to Promote Undergraduate Research and Biology Education at MCC*. (D.F. V—)

Dr. McKown, Kurt Chunn, and Rob Page presented information regarding the Campus Carry Policy. (D.F. V—157)

Mr. Turman moved to approve the Campus Carry Policy as presented. Mr. Stinnett seconded the motion, and the motion carried unanimously.

Dr. McKown presented information regarding action on an order cancelling the May 6, 2017, election. (D.F. V—159)

Mr. Sheehy moved to approve an order declaring John Douglas McDurham, unopposed candidate for election to trustee District 1 and Pauline Chavez, unopposed candidate for election to trustee District 3. Mr. McDurham and Ms. Chavez are elected to the offices and no election will be held in Districts 1 and 3 for those offices. Ms. Watley seconded the motion, and it carried unanimously.

Mr. Holt led a discussion regarding the future appointment of board members to various committees.
