Mr. Holt, Chairman of the Board, called the regular meeting to order at 7:13 p.m.

Mr. Holt introduced Dr. Paul Illich, President of Southeast Community College in Nebraska, who gave a presentation on his experiences as a college president.

Dr. Canham introduced Ms. Natalie James and Mr. Matthew Polk, who presented the Student Success Initiative on Project Link. (D.F. V—198)

Dr. McKown presented the following Consent Agenda Items for Board approval: 1) Consideration of and Approval of Minutes of August 1, 2017; August 14, 2017; and August 17, 2017; 2) Consideration of and Approval of Renewal of Tenured Faculty Contracts for the Year 2018-2019; 3) Consideration of and Approval of Revision to the Faculty Salary Schedule Policy, Administrative and Professional Staff Salary Schedule Policy, and Support Staff Salary Schedule; 4) Consideration of and Approval of Colleague Annual Maintenance Licensing Fee; 5) Consideration of and Approval of Trustee for Cooper Foundation; and 7) Personnel: Associate Director, Completion Center; Women's Golf Coach/Advisor; Dean, Arts and Sciences; Assistant Professor, Respiratory Care Technology (Tenure Eligible); and Program Director, Alternative Teacher Certification. Mr. Stinnett moved to approve the Consent Agenda Items as presented. Mr. McDurham seconded the motion,

and it carried unanimously.

Dr. Benson presented the financial report for July 2017. (D.F. V—200)

Mr. Sheehy moved to approve the financial report for July 2017 as presented. Ms. Chavez seconded the motion, and the motion carried unanimously.

Dr. McKown requested approval of the following Order Adopting District Property Tax Rate: (D.F. V—201)

McLENNAN COMMUNITY COLLEGE ORDER FOR 2017 TAX LEVY

It is ordered that the tax rate for the McLennan County Junior College District for the calendar year 2017, for the ensuing school year, be set at \$0.150346 per \$100 taxable value; and that tax for said calendar year 2017 for said ensuing school year, be, and it is hereby levied at said rate of \$0.150346 per taxable McLennan County valuation on taxable property in said district, \$0.035305 of such rate to be levied for debt service and \$0.115041 of such rate to be levied for maintenance and operation.

THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

THE TAX RATE WILL EFFECTIVELY BE RAISED BY 6.75 PERCENT AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$2.94.

It is resolved that an exemption from District taxes be allowed on the 2017 tax roll for all residential homesteads for which a valid residential homestead exemption application has been timely filed with the McLennan County Appraisal District, said exemption being for taxes applicable to the first twenty per cent (20%) of the appraised market value of such residential homesteads, or to the first \$5,000 of appraised market value of such residential homesteads, whichever is greater.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of persons 65 years of age or older be exempt, pursuant to Article VIII, Section 1-b of the Constitution of the State of Texas.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of individuals who are disabled be exempt from taxation, pursuant to Article VIII, Section 1-b of the Texas Constitution and Section 11.13 of the Property Tax Code. An individual who is eligible for both the 65 years of age or older exemption and the disabled person exemption shall be entitled to only one of these exemptions, and may choose either.

Be it further resolved that the McLennan County Junior College District hereby prescribes that Property Tax Code provisions implementing the tax relief amendment to the Texas Constitution concerning the appraisal of Agricultural and Timber Lands, shall be implemented and effective in the 2017 tax year as prescribed in the above cited statutes.

Be it further resolved that said tax be assessed and collected by the Tax Assessor-Collector of McLennan County, Texas, as provided by law.
