Mr. Holt, Chair of the Board, called the regular meeting to order at 7:00 p.m.

Dr. McKown introduced the guests present at the meeting.

The Board recognized Campus Police Officer Paul Serrano, who received the Waco Police Department's Life Saving Award.

Dr. McKown requested the approval of the commission of two new Campus Police Officers: Ricky Roberts and Michael Dorsey. She also asked the Board acknowledge their license as peace officers with the Texas Commission on Law Enforcement.

Ms. Chavez moved to approve the commission of police officers Ricky Roberts and Michael Dorsey, and to approve their licenses as peace officers with the Texas Commission on Law Enforcement. Mr. Turman seconded the motion. The motion carried unanimously.

Mr. McCleery administered the statement of office and oath of office to Officers Ricky Roberts and Michael Dorsey. (D.F. V—278)

Dr. Benson presented the budget information for the 2018-2019 Fiscal Year for the Board to review and consider. (D.F. V—281)

Mr. Sheehy moved to adopt the budget for 2018-2019 in the amount of \$56,401,343. Ms. Watley seconded the motion. The motion carried unanimously.

Dr. Benson presented the Capital Improvement Fund Budget for 2018-2019 for Board approval. (D.F. V—282)

Ms. Watley moved to adopt the Capital Improvement Fund Budget in the amount of \$1,678,455 for 2018-2019 as presented. Mr. McDurham seconded the motion. The motion carried unanimously.

Mr. Stinnett moved to approve the financial report for July 2018 as presented. Ms. Chavez seconded the motion. The motion carried unanimously.

Dr. Hills presented information on the appointment of the Science Lab Specialist position. (D.F. V—285)

Mr. McDurham moved to approve the appointment of Samantha Ostrander as the new Science Lab Specialist. Mr. Sheehy seconded the motion. The motion carried unanimously.

Dr. McKown requested approval of the following Order Adopting District Property Tax Rate. (D.F. V—286)

### McLENNAN COMMUNITY COLLEGE ORDER FOR 2018 TAX LEVY

It is ordered that the tax rate for the McLennan County Junior College District for the calendar year 2018, for the ensuing school year, be set at \$0.147696 per \$100 taxable value; and that tax for said calendar year 2018 for said ensuing school year, be, and it is hereby levied at said rate of \$0.147696 per taxable McLennan County valuation on taxable property in said district, \$0.032265 of such rate to be levied for debt service and \$0.115431 of such rate to be levied for maintenance and operation.

## THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST YEAR'S TAX RATE.

# THE TAX RATE WILL EFFECTIVELY BE RAISED BY 5.73% PERCENT AND WILL INCREASE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$0.39.

It is resolved that an exemption from District taxes be allowed on the 2018 tax roll for all residential homesteads for which a valid residential homestead exemption application has been timely filed with the McLennan County Appraisal District, said exemption being for taxes applicable to the first twenty per cent (20%) of the appraised market value of such residential homesteads, or to the first \$5,000 of appraised market value of such residential homesteads, whichever is greater.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of persons 65 years of age or older be exempt, pursuant to Article VIII, Section 1-b of the Constitution of the State of Texas.

Be it further resolved that \$12,000 of the assessed value of residential homesteads of individuals who are disabled be exempt from taxation, pursuant to Article VIII, Section 1-b of the Texas Constitution and Section 11.13 of the Property Tax Code. An individual who is eligible for both the 65 years of age or older exemption and the disabled person exemption shall be entitled to only one of these exemptions, and may choose either.

Be it further resolved that the McLennan County Junior College District hereby prescribes that Property Tax Code provisions implementing the tax relief amendment to the Texas Constitution concerning the appraisal of Agricultural and Timber Lands, shall be implemented and effective in the 2018 tax year as prescribed in the above cited statutes.

Be it further resolved that said tax be assessed and collected by the Tax Assessor-Collector of McLennan County, Texas, as provided by law.
