# **Degree Description**

In addition to meeting admission requirements to the College, individuals who wish to enroll in the Cosmetology program must meet entrance requirements as stated on the Cosmetology website or by contacting the program director for further information.

This program is designed to provide the students with the skills and knowledge for successful entry into the skin care industry. The Level I Certificate Program can be completed by a full-time student in 9 months.

Students who complete the program with a GPA of 2.0 or higher are eligible to receive a Certificate of Completion and take the Texas licensure examinations. This examination is the capstone experience.

#### Marketable Skills:

- 1. Understanding of applied knowledge in areas such as infection control, diseases and disorders, skin structure, pH of products, differences in acids, and ingredients to ensure the safety of the public. (CT)

## **CSME 1348 Principles of Skin Care**

An introduction of the theory and practice of skin care. Semester Hours 3 (2 lec/4 lab)

#### **CSME 1420 Orientation to Facial Specialist**

An overview of the skills and knowledge necessary for the field of facials and skin care. Semester Hours 4 (2 lec/6 lab)

#### CSME 1521 Principles of Facial/Skin Care Tech I

An introduction to the principles of facial and skin care technology. Topics include anatomy, physiology, theory, and related skills of facial and skin care technology. Prerequisites: None Semester Hours: 5 (3 lec/6 lab)

## CSME 1445 Principles of Facial/Skin Care Tech II

A continuation of the concepts in skin care and other related technologies. Topics include advanced instruction in anatomy, physiology, theory, and related skills of facial and skin care technology. Prerequisites: CSME 1348, 1420, and 1521. Semester Hours 4 (2 lec/6 lab)

## CSME 1547 Principles Skin Care/Facials/Related Th

In-depth coverage of the theory and practice of skin care, facials, and cosmetics. Prerequisites: CSME 1348, 1420, and 1521. Semester Hours 5 (3 lec/5 lab)

# CSME 2531 Principles of Facials/Skin Care Technology III

Advanced concepts and principles of skin care and other related technologies. Semester Hours 5 (3 lec/8 lab)
