## **NEW BUSINESS**

# Topic: Adding reserve textbooks to the library to assist students:

Discussion. Some faculty already do this. Various FC reps expressed reservations concerning the issue of free publisher provided books allocated for reserve, as this undermines financial compensation for the publisher and author. Various FC reps asserted books provided for reserve should be purchased.

Additional Notes and Questions from the discussion: The reserve for textbooks is two hours. How many students would make use of this? Should this be left up to the department or to individual instructors? Would this policy encourage some students to not buy the textbook all semester? Can the books only be made available for two weeks, until financial aid comes in? Would the administration each year purchase the books placed on reserve? Textbooks continue to increase in price, affecting a student's ability to purchase the

textbook. The Nursing department already makes the necessary books for their program available in the library.

# <u>ACTION REQUESTED</u>. FCP asked that ALL FC REPS take this issue to their constituents and return to our next meeting ready to report results with a view toward making a recommendation to VPI Fred Hills.

#### **Topic: Brightspace**

FCP asked that FC reps continue to convey Brightspace concerns to the representatives of the Brightspace Transition Team. This allows transition team members to recognize and address larger concerns that might be overlooked. As problems or frustrations are shared that others may be experiencing, a campus wide solution may be more easily imagined.

## **Topic: Change in Tobacco Policy**

New policy further limits areas on campus where individuals are allowed to smoke (away from many building entrances). The administration is moving toward a smoke free campus. The student response seems muted.

#### **Topic: Student Evaluations**

FC reps posed questions regarding student evaluations of instructors. How powerful student evaluations counted in the hiring and firing of faculty? What percentage of the instructor renewal decision comes from student evaluations? Do better evaluation questions need to be implemented? Because of the importance of this issue, FC created an Ad Hoc committee (Kent Hoeffner graciously agreed to chair).

#### **Topic: Shuttle Service**

Should the shuttle service hours be extended to aid disabled students after 3:30 (when the service shuts down)?

## **Topic: Remote Faculty**

Do the policies concerning remote faculty (those teaching from a distance) need to be examined, clarified, and/or re-evaluated?
