

## A FOND FAREWELL AFTER 16 YEARS OF SERVICE



Almost sixteen years have flown by since I came to the MCC Foundation. Developing funds is dependent on developing strong personal relationships, and I have been blessed and enriched in the many relationships which have flowered in these "MCC years." A true team, a true village, came to be with the wonderful MCC Foundation staff and board of trustees, with MCC staff, faculty, students, administration, and alumni, and with an engaged and supportive city and county. Businesses, individuals, organizations, and foundations came together to create incredible successes.

The MCC Foundation team saw net assets rise from \$3.4 million in 2001 to over \$16 million today and annual scholarships increased from \$178,000 to just under \$400,000. The MCC Foundation Board expanded and was enhanced with new gover-

nance procedure, diversity, and engagement.

Many major gifts were celebrated including a \$1 million grant from the Bernard and Audre Rapoport Foundation and a \$1.8 million bequest from the estate of Iris Jeffress. Campus improvements included the Bosque River Stage, Jim and Nell Hawkins' artwork at the new Science building, the Health Professions Complex and Simulation Laboratory, and the Highlander Legacy Plaza. New programs in the All Steinway Campaign and Annual Steinway Concert, popular Distinguished Lecture Series, and

Rapoport First Generation Scholarship program were funded and developed. Signature Foundation events, the Annual Golf Tournament and the Spring Hearts in the Arts Theatre Gala, moved from net revenues of a few thousand dollars to \$50,000 yearly from the golf tournament and a high of \$20,000 for the theatre gala. MCC employee giving increased from \$3,000 annually to over \$60,000 annually. The annual MCC Scholarship, Donor, and Alumni recognition grew from a few hundred attendees to over 1,000 annually, and moved from the Ball Performing Arts Center to the MCC Conference Center and finally to the Waco Convention Center to accommodate the larger audiences. An alumni organization, the Highlander Alumni & Friends Association, was formed and remains active under the MCC Foundation auspices.

Also, The MCC Foundation planned many special events such as the large retirement dinner for MCC President Dr. Dennis Michaelis, as well as the traditional inauguration ceremony for the succeeding MCC President, Dr. Johnette McKown and, as well, took the lead in organizing MCC's 35th, 40th, and 50th year celebrations. The 50th anniversary year saw a multitude of MCC division celebrations, reunions, and activities including MCC's Inaugural European Choir Tour and a grand 50th anniversary gala dinner followed by a Waco Symphony concert at Waco Hall and the initiation of MCC's first Hall of Fame with the introduction of MCC's first school song. The 50th anniversary resulted in a new 50th anniversary scholarship fund of over \$100,000.

No one individual can claim credit for these wonderful accomplishments. They were the result of warm, committed, and philanthropically-minded hard workers from all areas of the MCC constituency. For all the friendships, hard work, and grand giving, I send heartfelt thanks to all. I will forever be one of MCC's greatest

fans!

### Simple Guide to Planning Charitable Gifts & Avoiding Probate

**Question: What Can Be Given?** 

Answer: Depending on each charity's policies, gifts can include: Cash, Securities, Real Estate, Retirement Plan Assets, Life Insurance, Business Interests, Natural Resources, Collectibles, etc.

Note: The charitable gifting of appreciated assets such as securities or real estate can avoid income taxes on the appreciated assets that would have been due had the asset been sold first and then the proceeds transferred to the charity. Gifts of appreciated assets may be income tax deductible and valued at fair market value at the date of the gift.

### Question: How Can Giving be Accomplished?

Answer: There are many planned giving vehicles!
- Direct annual gifts or installment gifts over a period of years

- Testamentary gifts (through an estate by will)

- Charitable gift annuities and charitable trusts

- \*Beneficiary designations on life insurance contracts, IRAs/ Retirement Plans
- \*Payable on death clauses for checking accounts, brokerage accounts, savings accounts, certificates of deposit, commercial annuities

\*Beneficiary designations and payable on death clauses simplify estate administration in that these provide for payment to designated parties, avoiding probate and passing outside the will. This does NOT mean that they aren't included in and possibly taxable in the estate. Professional advisors should often be consulted before executing any transfer or gifting paperwork.
