Seven local and regional experts were featured at the 3rd Annual Tax and Financial Planning Institute at MCC on Nov. 13, where they provided valuable continuing education for the numerous attorneys, CPAs, trust officers, insurance professionals and financial planners who attended. Speakers covered topics including investment forecasting, charitable giving , family limited partnerships, sales tax issues and courtroom expert witness tips.

This is the third year the event has been hosted by the MCC Foundation, which encourages local training and networking opportunities for area professionals.

In his keynote address at the institute, internationally recognized, San Francisco-based economist Gary Schlossberg discussed the country's economic and financial market outlook through 2008. Schlossberg, vice president and senior economist for Wells Capital Management in California, is widely quoted in the industry and in media in the San Francisco Bay area, Japan and the United Kingdom.

FOUNDATION BOARD HOLDS FALL RETREAT

Encouraging more students to apply for scholarships, developing an infrastructure for alumni outreach, and hosting potential donors for dinners at the new Northwood House were some of the many ideas that came out of an Oct. 13 Foundation board retreat at the Highlander Ranch.

Along with looking ahead, the board also reviewed the Foundation's past performance. Net assets for the Foundation have grown from \$56,000 in 1990 to more than \$7 million this year. Annual Golf Tournament proceeds have grown from just more than \$8,000 in 1996 to \$39,000 this year. And, annual proceeds from Scholarship Night/Theatre Gala events have increased from about \$10,000 in 1997 to a high of \$27,097 in 2006.
