

# Donor Spotlight This Mother's Love is Eternal


A single mother who sacrificed her own dreams to care for her family is the inspiration for the newly endowed Charlene Cooper Blair Scholarship at the MCC Foundation. The scholarship was endowed by MCC graduates Arnold and Sarah Blair in memory of Arnold's mother who always wanted to be a nurse, but who, as a single mother, never had the time or money to go to college.



Arnold worked full time at the City of Waco for more than 20 years and attended MCC at night to obtain his degrees. He was one of the first students to enroll in the University Center and earned a B.B.A. in 2003 from the University of Texas at Arlington. He continued his education at UTA and earned his M.S. in Healthcare Administration in 2008. After graduation, Arnold attended additional MCC classes to become a licensed Nursing Home Administrator. He then launched a new career in elder care as an administrator at Wesley Woods Alzheimer's Care Center.

"We realize the importance of education and how the cost is sometimes prohibitive. We want this scholarship to help others in the Waco community."

Shortly after Arnold received his master's degree, he and Sarah married. Recognizing the importance of education and how the cost can sometimes be prohibitive, together they decided they wanted to give back to others because of the assistance they each had received. And, they wanted to honor the memory of Arnold's mother who had given up so much for him. The Charlene Cooper Blair Scholarship will be awarded



annually to any Wesley Woods or Lakeshore Village Nursing Home employee who may wish to further his or her education by becoming a Registered Nurse, Licensed Vocational Nurse or Certified Nurse's Aide at MCC or earn a Bachelor's of Science in Nursing from UTA.

From careers spent in service to others to their generosity in endowing a permanent scholarship fund to help others achieve their dreams, MCC alumnae Arnold and Sarah Blair are true examples of compassionate caring. Charlene Cooper Blair would be one very proud mom.

The MCC Foundation offers named endowed scholarships for a minimum contribution of \$15,000 or endowed presidential scholarships for a minimum contribution of \$25,000.

### A "Guns Up" Celebration

In celebration of Texas Tech University's partnership with McLennan



Community College's University Center, an upscale dinner reception was held in September at the stunning lakeview home of Cynthia and Ray Perry. Ray, a former MCC trustee, current MCC foundation board vice chairman, and a Texas Tech grad, along with his civic-minded wife, Cynthia, were the perfect hosts as dozens of local Tech alums, Tech administrators and MCC supporters gathered to toast the new opportunity for local students to begin their Texas Tech education without leaving Waco.

The University Center, now home to partnerships with the University of Texas at Arlington, Tarleton State University, University of Texas at Brownsville, University of Texas Medical Branch and Midwestern State University, allows students to enroll in upper-level courses on the MCC campus to obtain bachelor's, master's and some doctoral degrees. MCC is proud to welcome Texas Tech to the University Center, and the MCC Foundation looks forward to working with the Texas Tech Foundation in securing scholarships for MCC students to begin work at MCC and later transfer to Texas Tech.

Currently just under 900 students (not counted in MCC's enrollment) are enrolled in University Center studies.

### The Importance of Giving to MCC by: Harry Harelik

While there are a number of simple and taxwise ways in which to give to McLennan Community College, it is important to understand why that giving is important. MCC alumnus Robert Hawkins, in his recent acceptance of the Distinguished Alumni Award, said that when he paid his property taxes, he never begrudged the small amount of taxes going to MCC because he "knew that was an investment." What a brilliant way to view a tax!

Actually, ANY dollars going to MCC, whether through property taxes or through philanthropic giving, can be viewed as an investment in our community. MCC is one of the largest employers in McLennan County and, in addition, had over 9,100 students enrolled this fall. Even more importantly, more MCC students return to the area after their studies than do students from any other institution of higher learning. McLennan County's tax base, workforce and future leaders come from MCC alums, such as LaVega Superintendent Sharon Shields. McLennan County Clerk Andy Harwell and District Judge Vicki Menard.

Giving to MCC through the McLennan Community College Foundation is as simple as giving to any charitable organization. The MCC Foundation is a 501©(3) organization to which contributions may be income tax deductible. The Foundation can accept gifts from IRA rollovers as well as from donor advised funds and any business or individual. # Alumni Spotlight Alumni Association Celebrates Past, Future with Distinguished Alumni, Distinguished Young Leader Awards

The Highlander Alumni Association is pleased to announce the recipients of the association's first-ever Distinguished Alumni and Distinguished Young

Leader awards, which were presented Sept. 15 at the MCC Foundation Scholarship Night celebration.

Robert Hawkins,
Distinguished Alumni
Award recipient for
2009, has a long
association with MCC
that began in 1965
when he and others

petitioned for a junior college district to be created in McLennan County. He then worked for the passage of the successful bond election that resulted in the establishment of the college. In September of 1966, he was among the first 50 students to register for MCC classes and he was a member of the first twoyear degreed class of MCC, earning an Associate of Arts degree on May 30, 1968. He was the first person ever to transfer MCC credits out of the State of Texas; they were accepted at Syracuse University in New York. He later earned a bachelor's degree from the State University of New York and a graduate certificate from Texas A&M University. He served in the U.S. Army, the Army National Guard, the Texas State Guard and the U.S. Army Reserve. He retired as a colonel with 25 years'military service.

Hawkins' professional career was spent pioneering work in the area of career education and economic development training at Texas State Technical College, from which he retired after 29 years as Director of Special Programs. Among his numerous awards, honors and civic achievements are 20 years of service on the Bellmead City Council with

four terms as Mayor. He was nominated by MCC history instructor Tony Dudik.

Unlike the Distinguished Alumni Award recipient, the recipient of the Distinguished Young Leader Award knew little about MCC before he enrolled in 2007. As a native of Cameroon, Abanda Zofoa possessed limited familiarity with the college, the community, or the language of Central Texas. Despite his limited English skills, he earned nearly straight As while a student at MCC and was awarded his diploma with High Honors at the May 2009

commencement. He earned his outstanding GPA while working long hours as a security guard at HEB.

Zofoa served two years as president of the MCC International Student Club, where he led students in working for Habitat for Humanity and organized "Mock



UN" sessions to acquaint MCC students with the educational needs in other countries and how they contrast with the wonderful opportunities students have at MCC. Zofoa's future plans include earning a degree in Criminal Justice and attending law school. He was nominated by MCC English instructor Charlotte Laughlin.

The 2009 Distinguished Alumni and Distinguished Young Leader Award recipients were chosen by a selection committee comprising MCC Foundation board member Ray Perry, MCC retiree Mickey Reyes, and MCC employee (and alumnus) Gary Willis.
